Roshen Sale Discussion With Potential buyers

May 12 15

The potential buyers of ROSHEN Confectionery Corporation have not sent preliminary or final price offers, Managing Director of ICU Investment Group Makar Paseniuk has said. ICU Investment Group acts as an advisor to the seller. "Today the seller of Roshen did not receive any - preliminary and final - offers for the whole business via authorized advisors... We don't know who and how much is ready to pay," he said. "We're still discussing the preliminary interest of some potential buyers," Paseniuk said. He said that price expectations of both the seller and potential buyers depend on the prospects of the financial indicators of Roshen, which is defined by market, macroeconomic, and political factors. "The active phase of negotiations on the sale of Roshen business in Russia reached a stalemate after the arrest of assets of our client in Russia," he said.

ROSHEN Confectionery In Negotiations For Sale

Ukraine President, Petr Poroshenko owned ROSHEN Confectionery Corporation may be sold. Negotiations for possible sale of the Roshen confectionery are underway. According to Makar Pasenyuk, Managing Director of Investment Capital Ukraine (ICU) Group, handling the deal jointly with the Rothschild, there are both strategic and financial investors among potential buyers. Makar Pasenyuk added that though the sale of ROSHEN as a whole, including assets in Ukraine, Russia, Hungary, and Lithuania, is the priority, the company is not unlikely to be sold in parts, including its Russian assets.
